## Insurance-Setup-Rules

**Insurance:** Vendors agree to secure at its own expense a general liability insurance policy with an insurance company authorized to do business in Tennessee. Such policies shall name International Harvester Collectors of Tennessee Chapter 9 Inc. and International Harvester Collectors, Inc. as additional insured parties against all claims for injury or death to persons and injury to or destruction of property and may not exclude products completed operations hazard coverage. The minimum limits of said insurance policy shall be \$1 million combined single limit for bodily injury and property damage per person and per occurrence and \$2 million in aggregate, the terms of such coverage to coincide with the term of the show days. At least 10 days prior to commencement of the term of this agreement, vendor shall either furnish Rainprotection net with a certificate of insurance signed by an agent authorized to sign for issuing company or arrange to purchase the required insurance through the Rainprotection website link on the Tennessee Chapter 9 Website. If said certificate is not provided, Vendor shall not be allowed to participate in the event.
